- Will have the automatic berth to the finals for that weight class.
- Going to have the true third matches after the event.
 - o Location and date will be determined after the completion of the Non-Olympic World Team Trials process.
- Athletes can only hold one National Team spot and one stipend.
- Delays must be concluded by Friday, July 31st, 2027.
